NOTIFICATION

Whereas, the Election Authority (Chief Electoral Officer, J&K) had in pursuance of Rule 8 of J&K Panchayati Raj Rules, 1996 issued a notification under endorsement No.5311/CEO/PYT/Notification/2011/2817-28 dated 22-03-2011 calling upon the Panchayat Halqas falling in the blocks mentioned against each district to elect Sarpanches and Panches ;

Whereas, the above said Notification was issued for the conduct of Panchayat Elections in Block Wavoora, Block Uri, Block Lar, Block Nagam, Block Pahloo, Block Chenani, Block Vijaypur and Block R.S.Pura;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Baramulla vide his letter No.DEOB/Pyt/11/5101 dated 14-04-2011 has informed that the preparations for the conduct of Panchayat Elections i.e., filing of nominations, scrutiny, withdrawal, preparation/printing of ballot papers etc., has already been completed in respect of all the Sarpanch/Panch Constituencies, including Panchayat Halqa BLA-25-Dara Gutliyan, falling within the territorial limits of CD-Block Uri;

Whereas, as per the report of District Panchayat Election Officer (Deputy Commissioner) Baramulla, one Shri Mohammad Yousuf Awan S/o Gh. Hassan Wan R/o Dara Gutliyan Block Uri has filed a petition before the

Hon'ble High Court at Srinagar and the Hon'ble High Court has passed an order, which is reproduced as under:-

"The orders whereunder petitioners name has been deleted from Halqa Panchayat Dara Gutliyan shall remain in abeyance".

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Baramulla has requested the Election Authority (Chief Electoral Officer, J&K) to defer the election of Panchayat Halqa BLA-25-Dara Gutliyan Block Uri, till the outcome of petition from the Hon'ble High Court;

Now, therefore, in exercise of the powers conferred under section 36 of the J&K Panchayati Raj Act, 1989 read with rule 3 of J&K Panchayat Raj Rules, 1996, the Election Authority (Chief Electoral Officer, J&K) hereby rescinds its Notification issued under endorsement No.5311/CEO/PYT/Notification/2011/2817-28 dated 22-03-2011, in pursuance of Rule 8 of J&K Panchayati Raj Rules 1996, in so far as it relates, to the conduct of election to Panchayat Halqa BLA-25-Dara Gutliyan of Block Uri.
