JAMMU DATED THE 3RD MAY, 2011

Whereas, a detailed schedule for the conduct of General Election to the Panchayats in the entire State was issued by this office on 14th March, 2011;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Leh has requested for pre-ponement of Panchayat Election in respect of Kharu, Nobra, Panamic, Nyoma and Darbuk Blocks due to Leh festival which is scheduled to be held from 11th of June, 2011;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Bandipora vide his letter No.DEO/Election/2011/866-67 dated 03-05-2011, has also requested for re-scheduling the dates of election in Gurez and Tulail Blocks of District Bandipora due to the heavy accumulation of snow at Razdan Pass;

Whereas, the District Panchayat Election Officer (Deputy Commissioner) Kargil vide his letter No.DPEO-K/Elec/PE-MF/2010/13 dated 25-03-2011 has informed that two Blocks namely Zankar and Lungnak falling in Zankar Sub Division are presently cut off from the District HQ's of Kargil due to accumulation of snow at Pazla Pass and the road to these Blocks is likely to be re-opened only in the 2nd week of June and has therefore requested for re-scheduling of the dates of election in these two Blocks, so as to enable the electors to exercise their franchise;


Whereas, the District Panchayat Election Officer (Deputy Commissioner) Shopian has also requested for the re-scheduling of the date of election in Block Keller (Partly) due to shortage of staff;
